# AMEND definition for Roadside Stand

## **Article 10: General Regulations**

DELETE Section 1013.B.3 Signs, Agricultural displays and sales

AMEND Section 1014.A. by ADDING 10. Agricultural Value Added, Tourism and Related Uses parking standards, 11. Roadside Stand parking standards

### Article 16 Specific Use Standards

ADD Article 16 Specific Use Standards with the following Uses

1601 Agricultural Value Added, Tourism and Related Uses with allowances/standards for sale of on farm products, limited sales of off-farm products, allowance for direct marketing, food processing, related uses such as corn mazes, petting farms and similar uses and allowances through Planning Commission temporary permit approvals for non-farm related uses such as small scale entertainment events. Must meet sign & parking standards 1602 Roadside Stands with standards for structure setback, seasonal operation, sign & parking

### Article 37: Agricultural District, AG-1

AMEND Section 3701.A Permitted Uses by AMENDING Item 8 Roadside Stands

AMEND Section 3701.A. Permitted Uses by ADDING Item 17 Agricultural Value-Added, Tourism and Related Uses AMEND Section 3701.B. Special Uses by ADDING Item 13 Bed and Breakfast Operation, Item 14 Direct Marketing of Produce Buildings Greater than 2,500 square feet, Item 15 Restaurant Operations

### Article 55: Multiple Use District, M-1

AMEND Section 5501 A. Permitted Uses by ADDING Item 11 Roadside Standards and Item 12 Agricultural Value Added, Tourism and Related Uses
