

MARCH 2021 BOARD OF REVIEW MEETING SCHEDULE BEAR LAKE TOWNSHIP, MANISTEE COUNTY

The Bear Lake Township Board of Review for March 2021 will be held by electronic remote access, unless by the dates of the March Board of Review meetings it becomes lawful under state agency rules and stature for an in-person meeting to be held. Electronic remote access, in accordance with Michigan law, will be implemented in response to COVID-19 social distancing requirements and limitations on the number of individuals in a meeting hall.

Industrial	49.90%	1.00200
Residential	47.96%	1.04254
Personal	50.00%	1.00000

The above ratios and multipliers are subject to further review by the Board of Review, the Equalization Department, or the Michigan State Tax Commission.

Taxpayers are able to protest by letter provided protest is received by March 8, 2021.
